#### 1. Whose certificate(s) are needed?

- Write in the address, name, date of birth of the person whose certificate is needed.
- If there is a room number in the address, please make sure that the complete address, including the correct room number, is provided.
- If a previous name or common name is registered in the name section, the previous name or common name may be provided.

### 2. Which certificate(s) are needed?

- Write in the number of copies needed in the space for each certificate being requested.
- Multiple types of certificates can be requested with one request form.
- When you request a Certificate of Invalidated Residence Record, you cannot request a Certificate of Residence of another household that is in the same address or a Certificate of Residence of a person who belonged to the same household before the invalidation of the residence record due to a move-out, using the same request form.

# 3. Do the "Relationship/Name of the head of the household," "Registered domicile/Name of the head of the family," and other information need to be printed on the Certificate of Residence?

- If there are items that need to be printed on the requested certificate, please check the applicable boxes.
